



HCA SPONSORSHIP AGREEMENT

In order for a financial assistance request to be processed, a **Financial Assistance Application** must be completed, signed and submitted to the He Cures All Foundation along with this Sponsorship Agreement.

Requirements

In order to qualify for and to continue receiving support from HCA, you must agree to make certain dietary and lifestyle choices that are necessary to eliminate common food allergies and diet related illness. In addition, the following requirements apply:

- You must commit to following the protocol regimen as outlined, and take increasing financial responsibility for the protocol as your health is restored.
- You must commit to getting adequate rest and exercise as is possible, and to reading and assimilating the wealth of information that is available on our website and those which we make available to you.
- You must agree to regular, open and honest communications with your assigned Health Coach.
- A minimum of two posts per month are required in the HowIcuredmorgellons.com website forum that will document your progress along your healing journey.
- You must attend both Friday He Cures All Foundation Sponsorship meetings each month
- You must respond to at least two newbies pleas for help each month.

By signing the **HCA Sponsorship Agreement** and accepting support from the foundation, you agree to the use of your name (first name, last initial) and story by HCA on its website and/or other company promotional literature. It is up to the sole discretion of HCA Administrators to offer, continue or withdraw sponsorship support at any time for any reason.

Sponsorship Levels

It is the intention of the foundation to help people stabilize so that they may regain their health and return to a productive life. Therefore, all levels of sponsorship are structured so that participants in general take on greater responsibility for their protocol expenses over time as their health improves. Not only does this make sense from a fiduciary standpoint, (i.e. helping the most people possible with the resources available), but it makes sense as we celebrate the personal transformation of each individual that they take full responsibility for their choices and their health.

Eligible expenses paid under a sponsorship are paid directly to providers, not to the sponsorship recipient. As the foundation subsidy decreases, the recipient must reimburse the foundation for the balance of the monthly cost for the protocol. There are three levels of sponsorship available depending on the needs and circumstances of the recipient:

Primary Sponsorship (12 Month Program) – This program is for those who are in severe financial hardship due to chronic illness related to a compromised bioterrain.

- First Quarter – 100% Subsidy
- Second Quarter – 75% Subsidy
- Third and fourth Quarter – 50% Subsidy

Secondary Sponsorship (6 Month Program) – This program is for those who are in moderate financial hardship due to chronic illness related to a compromised bioterrain.

- First Two Months – 100% Subsidy
- Third & Fourth Month – 75% Subsidy
- Fifth Month – 50% Subsidy
- Sixth Month – 25% Subsidy

Lifeline Sponsorship (Up to 3 Months) - This program is for those who are in temporary financial hardship due to an unforeseen emergency with chronic illness due to a compromised bioterrain.

- First Month – 100% Subsidy
- Second Month – 50% Subsidy (If Needed)
- Third Month – 25% Subsidy (If Needed)

In the event the He Cures All Foundation decides to continue your sponsorship beyond the original agreement, we will continue to provide a 25% subsidy.
